**956.01 ESTABLISHMENT.**

The Governing Body of the Town of Nutter Fort hereby finds and declares that the needs, interests and welfare of the citizens of Nutter Fort require the establishment of a Nutter Fort Parks, Recreation and Wellness Commission to establish, supervise, and direct the general recreational activities, and to control the use of the Town's physical facilities, used for the recreation and enjoyment of and by the citizens of Nutter Fort and others who may avail themselves of these facilities.

**956.02 POWERS AND DUTIES.**

The Town of Nutter Fort does hereby establish the Nutter Fort Parks, Recreation and Wellness Commission, which will be referred to herein after as the "Commission".

The Commission shall direct and control the use of all Town facilities used and available for recreational purposes. The Commission shall meet at the direction of the Chairman or at the request of a majority of the Commission members. They shall meet at such place and time as the Chairman directs. Any member who misses three (3) consecutive meetings, without good cause, will be replaced.

The Commission shall require persons, individuals or groups desiring to hold special activities in or on such Town facilities to submit a written application at least thirty (30) days in advance of the date of use, where practical. "Special activities" means use of the facilities that is aside from the normal, everyday use that has been the person or group, the nature of the activity planned, the number of persons involved, and the amount of any charge, admission, or donation, if any. Also, the name of the person who will be in charge of the activity.

**956.03 MEMBERS.**

The commission shall be composed of five (5) members, all of whom must reside in the Town of Nutter Fort.

**956.04 NOMINATION; APPOINTMENT; TERM.**

All Commission members shall be appointed for specific terms of service by the governing body of Nutter Fort. Any member of the governing body may nominate persons for service on the Commission, and the appointments of such persons shall be approved by a majority of those voting. Nominations and appointments shall be made at the regular meetings of the governing body. A chairman of the Commission shall be elected by and from the members of the Commission by a majority vote on a year-to-year basis.

Members will be appointed for not more than a three-year term. Two members will be appointed for three (3) years, two members will be appointed for two (2) years and one member will be appointed for one (1) year. The member that is appointed for the one (1) year term, if reappointed will serve a three (3) year term.
